- 2. The Admission in the school will be granted after the "Personal Interaction" with the child to be held on:

- 3. The parents / guardians of the successful candidates are advised to deposit the school fee on 20th of March, 2025 {1st TO 4TH Class}, 21ST of March, 2025(5TH TO 7TH Class} AND 22ND of March, 2025(8TH TO 10TH Class}. The Students changing their schools must submit their previous "School Leaving Certificates". The D.O.B Certificate/s for fresh admission in 1st class must have been issued by the Municipal Authorities (Urban Area)/ Concerned Police Authorities (Rural Area).
- **4.** Students must bring their previous year's report card on the assigned date of the 'Personal interaction' as mentioned above.
- 5. <u>ADMISSION</u> granted as per the above mentioned dates be accepted, otherwise it will be considered cancelled, and preference will be given to the next/ waiting candidate/s.
- **6.** No "School Leaving Certificate/s" of the previous school will be accepted without the "Counter Signatures" of the concerned Education Officer.
